



EVENT AGREEMENT

THIS AGREEMENT is entered into this 28th day of Oct 2011, by and between the Apple River Family Campground (ARFC) and Event Group identified below.

IN CONSIDERATION of the mutual promises set forth herein, and for consideration, the receipt of which is hereby acknowledged upon the following terms:

- 1) **EVENT GROUP:** OSFA Pig Roast
 - 2) **TITLE OF EVENT GROUP:** Pig
 - 3) **EVENT CONTACT/AUTHORIZED AGENT:** Melissa Winkel

 - 4) **NAME/PLACE OF EVENT:** Apple River Family Campground,
345 Church Hill St., Somerset, WI 55
 - 5) **DATE OF EVENT:** Friday July 20, Saturday July 21st, Sunday July 22nd
 - 6) **TIME OF EVENT (start/end):** noon Friday to 4pm Sunday 2012
 - 7) **EVENT FEE:** Event Group shall pay a fee of \$ 25.00, to be paid as follows,
 - A) A deposit of ~~\$300.00~~ 500.00 is due upon execution of this agreement, see attached for additional
 - B) The balance of \$ 2,000, to be paid before end of the event.
 - 8) **LOCATION OF EVENT/ACCOMMODATIONS:**
 - (a) Area of use is determined to be meadows area
- Use of Pavilion is included in this event.
- (b) Day passes are included in this contract and all Event participants **MUST** wear special VIP wristbands at all times.
 - 9) **CANCELLATION:** If Event Group, cancels event less than 4 weeks before the date of event, Event Group shall forfeit the Deposit of \$300.00 to ARFC, as liquidated damages.
 - 10) **EVENT GROUP RESPONSIBILITY:** Event Group is responsible for cleaning all trash and/or animal excrement from event. ALL trash is to be deposited in dumpsters located in campground area.
 - 11) **PERMITS:** Event group warrants and represents that it has obtained all approval, permits, licenses and/or variances necessary for this event.
 - 12) **TERMINATION:** ARFC may refuse or terminate the event due to violation of any law or regulation by the Event Participant or any situation that the Party reasonably believes may be hazardous to any person and/or property.

13) **PARKING:** Designated by ARFC.

14) **ADDITIONAL PROVISIONS:** The Parties agree to the following additional terms,

Event Group will provide their own security.

This contract covers ONLY the area as described in #8 of this contract. Any and all other camping/cabin rental/tubing will be under ARFC control. All shower/restroom and pool areas will remain accessible to the public.

Pool hours are from 9 a.m. to 11 p.m. (18+ from 10 p.m. to 11 p.m.) Thur/Fri/Sat.
